1. This agreement constitutes an order for photography services, which involves digital images, photographs, digital albums and prints. It is understood that any and all proofs, sample prints and digital files or images remain the property of the photographer and they may be used for advertising, display and any purpose thought proper by the photographer. Uses may include posting to photographers web site or advertising through print, bridal show or other mediums. By signature, bridal party agrees to terms of this contract.
2. Although utmost care will be given with the creation of digital images, photographer limits any liability for loss, damage or failure to deliver images as a result of any mechanical or equipment malfunction to the return of deposits made pro-rated by estimated number of lost images. After photography is completed, all digital images will be securely transferred to CD or DVD for archiving purposes. CD/DVDs are not permanent archives and should be stored carefully and re-copied by customer every 2-5 years.
3. Upon signature and receipt of deposit, photographer reserves the time and date agreed upon, and will not make other reservations for that time and date. For this reason, all deposits are non-refundable, even if date is changed or photography is cancelled for any reason.
4. In the event of unforeseen medical emergency in which photographer can not photograph wedding, photographer will make reasonable effort to arrange for a substitute professional photographer to conduct photography. If no professional substitute is available, bridal party agrees to limit damages to full refund of payments made only.
